"All in" Service Packages

"All in" / "All in Annual" service packages include "All in Economy" / "All in Annual Economy", "All in I" / "All in Annual I", and "All in II" / "All in Annual II" pricing packages that encompass two services: "Broadband Internet" and "Wink TV." The packages "All in III", "All in Annual III", "All in IV", "All in Annual IV", "All in V" / "All in Annual V" include three services: "Broadband Internet", "Wink TV", and "Fixed Line Telephony".

- 1.1. By subscribing to the "All in annual" tariff packages specified in Table 2 for a period of 1 (one) year, the Subscriber begins to use the Services at the rates (monthly fees) of the "All in annual" tariff packages and agrees to continue using the selected "All in annual" tariff packages for 1 (one) year (365 (three hundred sixty-five) days) from the activation date of the Service. After 1 (one) year (365 (three hundred sixty-five) days), the Subscriber's contract will be automatically renewed for another 1 (one) year (365 (three hundred sixty-five) days). The Subscriber may refuse the automatic renewal condition when signing the subscription contract and up until the completion of the 1-year subscription; in this case, after 1 (one) year (365 (three hundred sixty-five) days), the Subscriber will automatically start using the rates (monthly fees) of the "All in" tariff packages. 17
- 1.2. 1.2. Upon subscribing to the "All in annual" tariff packages specified in Table 2, the Subscriber receives the following benefit:
 - i. Within the framework of the "All in annual" service package, in addition to Table 2, the Subscriber receives a 50% (fifty percent) discount on the monthly fee for the first 3 (three) months, meaning that the primary

Services provided under this tariff package will be offered at a 50% discount during the first 3 months if the subscription is made exclusively through the Operator's Sales and Service Centers and Online subscription. This 50% (fifty percent) discount condition for the monthly fees during the first 3 (three) months does not apply if the subscription is made through other channels.¹⁸

- ii. Within the framework of the "All in annual" service package, in addition to Table 3, the Subscriber receives a 50% (fifty percent) discount on the monthly fee for the first 4 (four) months, meaning that the primary Services provided under this tariff package will be offered at a 50% discount during the first 4 months if the sale is made through Active Sales, Agents, and Telemarketing. This 50% (fifty percent) discount condition for the monthly fees during the first 4 (four) months does not apply when sales are made through other channels.¹⁹
- Within the framework of the "All in annual" service package, in addition to Table 2, the Subscriber receives three visits for In-house Technical Support services without any additional charge.
- 1.3. The 50% (fifty percent) discount condition for the monthly fees for the first 3 (three) months, as specified in clauses 1.2 (i) and (ii), and the 50% (fifty percent) discount condition for the monthly fee for the first 4 (four) months do not apply to the "All in" tariff packages specified in Table 1, as well as to the "All in annual Economy" tariff package specified in Table 2
- 1.4. If the Subscriber joins the "All in annual" service package as specified in clause 1.2 of these terms and temporarily suspends the provision of Services within 1 year (365 calendar days) from the activation of the Services according to the specified terms, or if the provision of Services is suspended due to delayed payments, then the duration of the 50% discount mentioned in clause 1.2 for the first three/four months of this tariff package will not be extended by the duration of the suspended period of Service provision.
- 1.5. Upon subscribing to the "All in annual" tariff packages for a period of 1 (one) year, in the event of a temporary suspension of service provision or suspension of services due to delayed payments, the mandatory subscription term for the respective services/tariff package and the terms of the "All in annual" tariff package, including the duration of the included services and the monthly fee for the tariff package, will be extended by the duration of the suspended period.
- 2. Conditions for changes to tariff packages from the current tariff packages.
- 2.1. If a subscriber with a current subscription for 1 (one) year switches to any of the "All in annual" or "Wi-Fly annual" tariff packages specified in Table 2 of these terms for a period of 1 (one) year, then the existing contract will be renewed for another 1 (one) year subscription. The Subscriber will cease to receive the terms of the previous tariff package and will begin to use the terms of the new tariff package.
- 2.2. If a subscriber with a current subscription for 1 (one) year switches to any tariff rate of the "All in" tariff package or "Wi-Fly" tariff package specified in Table 1 of these terms, then the Subscriber will cease to receive the terms of the previous tariff/services package and will begin to receive the terms of the new tariff/services package. However, the Subscriber will continue to use the new tariff/services package under the mandatory annual subscription conditions until the originally specified period for it expires.
- 2.3. If an existing subscriber switches to any tariff rate of the "All in" tariff package or "Wi-Fly" tariff package specified in Table 2 of these terms without a 1 (one) year subscription condition, then the Subscriber will cease to receive the terms of the previous tariff/services package and will begin to receive the terms of the new tariff/services package without the 1 (one) year subscription condition.
- 2.4. If an existing subscriber switches to any tariff rate of the "All in annual" tariff package or "Wi-Fly annual" tariff package specified in Table 3 of these terms without a 1 (one) year subscription condition, then the Subscriber will cease to receive the terms of the previous tariff/services package and will begin to receive the terms of the new tariff/services package under a 1 (one) year subscription condition.

- 3. Conditions for changes between the tariff packages specified by these terms.
- 3.1. If the Subscriber changes the tariff package during the period of 50% discount on the Services specified by these terms by switching to any tariff rate of the "All in annual" tariff packages or any tariff rate of the "Wi-Fly annual" tariff package, they will continue to use the Services provided under the new tariff package at a 50% discount until the originally specified period for the 50% discount expires. During the period mentioned in this clause, if the Subscriber switches to the "All in," "All in annual Economy," "Wi-Fly," "Wi-Fly annual Economy," "Wink TV," or "Fixed Line" tariff packages, the Subscriber will cease to use the Services at a 50% discount.
- 3.2. If the Subscriber changes the tariff package between the "All in annual" tariff packages specified in Table 2 of these terms, the Subscriber will cease to receive the terms of the previous tariff/services package and will begin to receive the terms of the new tariff/services package. However, the Subscriber will continue to use the new tariff/services package under a mandatory annual subscription condition until the originally specified period for it expires. If the monthly fee for the new tariff rate/tariff package is at least not higher than that of the previous tariff package but lower, the Subscriber is obligated to pay a one-time transition fee of 2000 AMD.
- 3.3. If the Subscriber has joined any of the "All in annual" tariff packages specified in Table 2 of these terms for a period of 1 (one) year and switches to any of the "Wi-Fly annual" tariff packages, and if the monthly fee for the new tariff rate/tariff package is at least not higher than that of the previous tariff package but lower, then the Subscriber is obligated to pay a one-time transition fee of 4000 AMD.
- 3.4. If a subscriber with a current subscription for 1 (one) year switches to any tariff package without a 1 (one) year subscription condition, they are obligated to pay the Operator the full current debt and a cancellation fee of 15,000 AMD and will begin to receive the terms of the new tariff/services package without the 1 (one) year subscription condition.
- 3.5. If the Subscriber switches from a tariff package of the "All in"/"All in annual" service package that includes the "Turbo" service to another tariff package that does not include the "Turbo" service, the monthly fee for the "Turbo" service will automatically come into effect within the new tariff package from the moment of the transition. In this case, the subscriber has the right to refuse the "Turbo" service. If the subscriber refuses the "Turbo" service, the TurboSpeed AX1800 device will be uninstalled from the Subscriber's residence according to the procedure established by the Operator.
- 3.6. If the Subscriber switches from any tariff package of the "All in"/"All in annual" service package that does not include the "Turbo" service to another tariff package that includes the "Turbo" service, the monthly fee for the "Turbo" service will automatically cease to apply within the new tariff package from the moment of the transition.
- 3.7. The Subscriber has the right to refuse the "Turbo" service at any time. In this case, the Operator will uninstall the TurboSpeed AX1800 device from the Subscriber's address, and the monthly fee for the service will cease to apply within the Subscriber's tariff package.
- 3.8. n the event of termination of the Subscriber Agreement signed between the Operator and the Subscriber (whether unilateral or bilateral), the TurboSpeed AX1800 device is subject to return to the Operator.
- 3.9. The mandatory subscription term for the "All in annual" tariff packages is considered complete when the Subscriber has used the subscribed service package/tariff package for a minimum of 1 year (365 (three hundred sixty-five) days) from the activation date of the included Services. If the subscription to the "All in annual" tariff packages is terminated before the specified term expires due to the Subscriber's actions or inactions, they are required to pay the Operator the full current debt and a cancellation fee of 15,000 AMD:
- 3.10. In the case of unilateral termination of the Subscriber Agreement by a Subscriber who is a natural person, the termination of the Subscriber Agreement by the Operator is carried out exclusively upon the Subscriber's payment of the value of the Services rendered to them until the date of termination of the Subscriber Agreement (including the monthly subscription fee), as well as any other payments stipulated by the Operator for unilateral termination of the Subscriber Agreement (penalties, fines, cancellation fees), if such payments exist.
